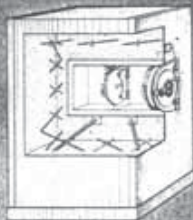
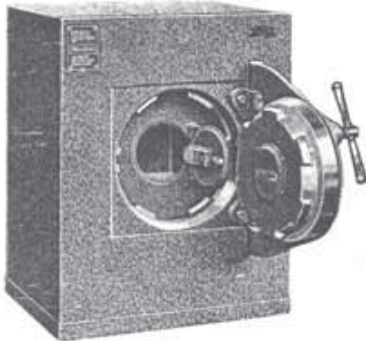

Phantom view through standard concrete block showing interior and reinforcing.



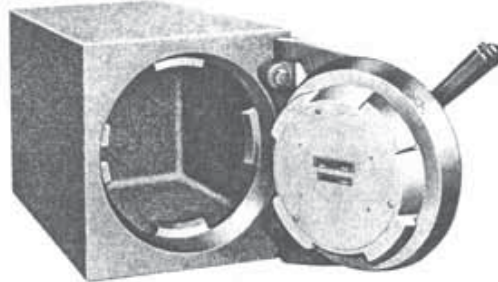
Section Showing Partition and Inner door.

**MOSLER  
TYPE "E" MONEY SAFES**

The door of the type E money safe is case-hardened steel. This produces an exterior that is highly resistant to drills and mechanical tools. The soft, tough inner core resists explosive attack.

NOTE 1: The Change Fund Compartment dimensions are: 8" diameter x 4½" deep. The clear depth is 3¼". The volume is 195 cubic inches.

The daily Receipts Compartment is 9¼" in diameter x 10¼" deep. The clear depth is 9¼". The volume is 730 cubic inches.

NOTE 2: No. 00EV-6 Money Safe has the same dimensions as No. 00EV except the Daily Receipts Compartment which is 16¼" deep. The clear depth is 15¼". Volume, 1060 cubic inches. Approximate net weight 260 lbs.
